**Dear User!**

We care about your privacy and want you to feel comfortable while using our services. Therefore, below we present you the most important informations about the principles of processing your personal data by us and cookies, which are used by our Service. This information has been prepared taking into account GDPR, the General Data Protection Regulation.

## PERSONAL DATA AND PRIVACY

If you intend to create a User Account and use our Services, you will be asked to provide us with your personal data. Your data is processed by us for the purposes indicated below, related to the functioning of the Website and the provision of the services offered therein ("Services").

### **Purpose of Processing:**

Depending on what you decide on, it could be:

- Provision of services offered on the Website
- Direct marketing of services offered

### **Basis of Processing:**

1. A legal obligation on us, e.g. related to accounting (Article 6(1)(c) GDPR)
2. Your consent given on the Service - if you choose to give it (Article 6.1.a GDPR)
3. The contract for the provision of services or actions taken at your request to conclude it (Article 6(1)(b) of the GDPR)
4. Our legitimate interest to process the data in order to establish, assert or defend possible claims (Art. 6(1)(f) GDPR)
5. Our legitimate interest (Article 6(1)(f) of the GDPR) in:
  - a) profiling for marketing purposes
  - b) data processing for analytical and statistical purposes of customer satisfaction surveys

### **Data Submission:**

- Voluntary, but in some cases may be necessary to enter into a contract

### **Effect of not providing data:**

Depending on the purpose for which the data is provided:  
- inability to register on the Website  
- inability to use the Website or participate in a Sports Event

### **Ability to revoke consent:**

- any time

Processing remains lawful until you withdraw your consent

---

## POSTING CONTENT ON THE SITE

Some of your information, such as:

first name last name

city/town

sports club

data related to results in a sporting event

will be visible to other users of the Service - on lists of results published by Organizers of Sports Events in which you participate.

---

## PROFILING

As part of the Service, we may automatically tailor certain content to your needs, i.e., perform profiling, using the your personal information for this purpose. Before we perform profiling based on which decisions are made: producing legal effects on you that affect you in a similarly significant way, we will ask you for your consent.







Remember that you can revoke your consent at any time. The processing of data until you revoke your consent remains lawful.

## PERIOD OF PROCESSING

will only process your data for as long as we have a legal basis to do so, which is:

-  we are no longer under a legal obligation to process your data możliwość dochodzenia roszczeń related to
-  the contract concluded by the Website by the Parties withdrawing their consent to data processing if it was
-  the basis for such processing
-  your objection to the processing of your personal data is accepted - where the basis for the processing of your data was a legitimate interest of the controller or where the data was processed for direct marketing purposes, including profiling

- whichever is applicable in your case and whichever occurs latest.

## DATA SECURITY

When processing your personal data, we use organizational and technical measures in accordance with applicable law, including the use of encryption of the connection using an SSL certificate.

---

## YOUR PRIVILEGES

You have the right to request:

- a) access to your personal data
- b) correction of your personal data
- c) deleting your personal data
- d) restriction of processing
- e) transfer of data to another controller

And also the right:

To object at any time to the processing of your data:

for reasons related to your particular situation, to the processing of personal data concerning you based on Article 6(1)(f) of the RODO (i.e. on legitimate interests pursued by the controller), including profiling on the basis of these provisions - if applicable, where personal data is processed for marketing object at any time to the processing of your direct data, including profiling, to the extent that the processing is related to such direct marketing.

Contact us if you wish to exercise your rights.

If you believe that your data is being processed unlawfully, you can lodge a complaint with the supervisory authority.

## COOKIES

Our Service, like most websites, uses so-called cookies. These files:

- are stored in the memory of your device (computer, phone, etc.)
- enable you, among other things, to use all features of the Website without causing you changes to your device settings

Using the appropriate options of your browser, you can at any time:

- delete cookies
- block the future use of cookies

On this Site, cookies are used for:

- remembering your session information
- statistical marketing
- to make features of the Service available
